Eye Contact

If splashed into the eyes, flush with clear water for 15 minutes or until irritation subsides. If irritation persists, call a physician.

Skin

In case of skin contact, remove any contaminated clothing and wash skin thoroughly with soap and water.

Inhalation

If overcome by vapor, remove from exposure and call a physician immediately. If breathing is irregular or has stopped, start resuscitation; administer oxygen, if available.

Foam, water spray (fog), dry chemical, carbon dioxide and vaporizing liquid type extinguishing agents may all be suitable for extinguishing fires involving this type of product, depending on size or potential size of fire and circumstances related to the situation. G. REACTIVITY

Ventilation
